Our consolidations vary from year to year, and this may affect yearly numerical rankings. City/state designations are derived from USPS's payment records and may not be the contractor's primary location. The information on this list has not been audited and thus may not be entirely accurate. Please contact David Hendel if you have questions or know of discrepancies.
